

Pilot Program 2024





The North American Food Systems Network will host a **pilot program** of its CARAT tool with **six (6)** US communities in 2024.



This pilot will be conducted in partnership with the Food and Agrarian Systems group at **Indiana University**.

The objective: to learn from the collective experiences of six community-based CARAT lead facilitators and their collaborators to:

- support six communities to fully complete CARAT audits;
- create a CARAT facilitation training for national release;
- improve the CARAT tool based on pilot user input;
- **strengthen** CARAT's accessibility for all communities.

ELEMENTS OF THE PILOT:



- **Team Approach** Pilot facilitators will prioritize the activity of pulling together diverse stakeholders to contribute to their CARAT audits.
- Transparency Pilot communities will share their findings with cohorts. Organizers will spotlight participating communities.
- **Technical Assistance** Pilot organizers will provide guidance monthly in cohort meetings and on-call as needed.
- Turn Toward Transformation Pilot communities will use their CARAT audit to identify and commit to work on priorities discovered in the process.



ELIGIBILITY FOR THE PILOT:

• **Experienced Lead Facilitator** - Eligible communities will have a committed lead facilitator with experience in stakeholder collaboration and project coordination.

• **Support from Community** - Eligible communities will have the capacity to support their lead facilitator by ensuring that their paid role includes an average of 10 hours/week for CARAT facilitation throughout the six month pilot timeline.

COSTS FOR THE PILOT:



 No Charge from Pilot Organizers - NAFSN and IU will provide guidance to CARAT pilot communities free of charge.

• No Charge for Use of CARAT - CARAT is offered to the public as a <u>free, open-access tool</u>.

• Costs of a CARAT Audit - In addition to supporting the work of their CARAT lead facilitator, communities will also be expected to cover any additional costs incurred for collaboration work.

VISIBILITY OF THE PILOT:



CARAT pilot communities will have the opportunity to:

share their knowledge with a national audience;

• feature their approaches to community engagement;

help other communities learn from their experiences.



USING CARAT AS A COMMUNITY

CARAT can be used to establish a baseline, set priorities, and measure change over time.

CARAT can be matched with technical support to guide a community through discovery, regardless of entry point or level of expertise.

CARAT results in a summary that can be easily shared to convey complex discoveries to other community stakeholders, funders & decision-makers.

CARAT adopts a social-ecological systems perspective on the interdependency of humans and the environment.
